

2024 COLORADO BRANCH OF NORTH CENTRAL CARAVAN ITINERARY

Meet locations and times TBD pending feedback from Caravan participants. If you are in Nebraska, South Dakota, Iowa or Minnesota and wish to request a stop along the route that is not listed here, please do so.

FIRST LEG August 23 472 miles, 7hr drive time Allows 9-11 hrs with stops

Southern CO participants meet at Monument Park and Ride to leave at 7 am.

I-25 to E-470: 34 miles, 30 minutes, South Denver Metro participants meet at Cabelas parking lot in Lone Tree, CO to leave at 7:45am (confirmed stop).

E-470 to I-76 Hudson: 52 miles, 45 minutes, North Denver Metro participants meet at Loves Travel stop in Hudson, CO, to leave at 8:45 am (confirmed stop)

I-76 to Sterling, CO: 95 miles, 1 hr 15 minutes Ft Collins/Loveland metro area participants meet at CDOT Sterling Rest Area to leave at 10:30am. (confirmed stop). Recommend all participants top off fuel during this stop at Realta Travel stop across I-76 from Rest area

I-76/I-80 to Grand Island,: 279 miles, 4 hrs to arrive 4-6pm for overnight stay. Choose accommodations within a half mile or so of Candlewood Suites, US281 and W Faidley Ave.

SECOND LEG August 24 253 miles, 4 ½ hrs drive time, Allows 8-9 hrs with stops:

All participants, including CO and Western NE meet at Home Depot Parking lot behind Candlewood Suites to leave at 9am. (Confirmed stop)

Grand Island to Columbus via US30: 67 miles, 1 hr 15 minutes. Easter NE participants meet at site TBD to leave at 10:30am (tentative pending feedback)

Columbus to Yankton, SD via US-31: 110 miles, 1 hr 55 minutes arrive 12:30pm to parade Broadway

Yankton to Jerry's Chevy via US-31 and SD-46: 51 miles, 1 hr arrive 1-2 pm, stay 2+ hrs for social and meal, join South Dakota Caravan.

Jerry's Chevy to Sioux Falls Staybridge Suites. Empire Mall via I-29: 31 miles, 30 minutes arrive 5-6pm for overnight stay. Other accommodations can be found within a half mile of Staybridge Suites

THIRD LEG August 25 392 miles, 6 ¼ hrs drive time, Allows 7 hrs with stops:

Leave at 9 am from Sioux Falls to Rochester, MN via I-90: 238 miles, 3 hr 45 minutes

Rochester to Wisconsin Dells Chula Vista Resort via I-90: 154 miles, 2 hr 30 minutes arrive 4-5 pm for two night stay.

DEPART per NCC itinerary August 27 for Bloomington, Effingham, IL and Bowling Green, KY .
