MARKETING AND COMMUNICATIONS: AMERICA'S SPORTS CAR MAGAZINE IS A QUARTERLY PUBLICATION MAILED TO 25,000 HOUSEHOLDS, CLUBS AND BUSINESSES THAT EDUCATES READERS ON HAPPENINGS AT THE NCM AND CORVETTE HISTORY, INCLUDING ARTICLES ON SPECIFIC EXHIBITS TO INFORM THOSE THAT CANNOT PHYSICALLY COME TO THE MUSEUM. NCM E-NEWS IS A WEEKLY EMAIL COMMUNICATION SENT TO OVER 80,000 SUBSCRIBERS WITH SHORTER EDUCATIONS STORIES/VIDEOS AND NEW ITEMS ON CORVETTE, THE MUSEUM AND UPCOMING CAR SHOWS AND EVENTS. THE MUSEUM WEBSITE IS A RESOURCE FOR RESEARCHING CORVETTE, INCLUDING DETAILS ON EVERY MODEL YEAR. LIBRARY & ARCHIVES RESOURCE CENTER: THE RESOURCE CENTER IS THE REPOSITORY FOR ALL MATERIALS DOCUMENTING THE PAST, PRESENT AND FUTURE OF CORVETTE, CORVETTE ENTHUSIASTS AND THE CORVETTE MUSEUM. THE MATERIAL MANAGED AND PRESERVED INCLUDES AUDIO AND VISUAL MEDIA - BOTH DIGITAL (DVDs) AND MAGNETIC (VHS AND BETA TAPES), PERIODICALS, BOOKS, DRAWINGS, PAINTINGS, POSTERS, MEMORABILIA AND DOCUMENTS INCLUDING SOME IMPORTANT HISTORICAL MEMORABILIA PLUS BUILD SHEETS.
